1. Copy of the Will of Mrs. Middleton Edwards

I am putting this document in the College safe. In case of Mrs. Edwards' death while Mrs. Scott and I are in the United States during the months of August, September, October and part of November, access to the will may be requested by Bay Lazaraki Kurkcuoglu, (lawyer) whose office is in the Karaköy Palas, Karaköy (Galata) or by Miss Phoebe Clary. Bay Kürkcüoğlu and I are co-executors of Mrs. Edwards' will as it affects her properties in Turkey. I authorize access to the will by one or both of these parties.

2. The Will of Harold L. and Eveline T. Scott

A copy of this will is in the College safe. I think it prudent for the College authorities to be told something about the provisions of our will and the location and nature of our moderate estate. There is always the thousand (or more) to one chance that something decisive might happen to us both simultaneously. It would be of importance for the College authorities to have this information because we are leaving all we possess to the Trustees of Robert College for the benefit of the Robert College Library.

The executrix is our friend, Miss Eleanor S. Woton, 21 Hoskier Road, South Orange, New Jersey. The lawyer who drew the will for us is Mr. Michael N. Chanalis, the firm of Chanalis, Lynch and Maloney, 9 Clinton Street, Newark 2 New Jersey.
