# Follow-up items to meetings 7/31/91 to 8/6/91

During our various meetings, we discussed your providing us with additional information and materials upon your return to Turkey, if at all possible. In order to assist you, I have prepared the following check list:

- 1) Information to be supplied:
  - (a) Measurements of the piece at the Antalya Museum (as per drawings marked by John Horn)
  - (b) Fax to us after meeting on August 12, 1991 with sculptor Nejat Ozatay: the material to be used in making the cast, the cost and the tentative date by which we will have the cast.
- 2) Report of inspection on August 5, 1991.
- 3) We will review article you have prepared for German text on Levy/White Herakles (including response to Vermuele contentions). (You will send draft to us by fax in a week or so, and we will respond immediately.)
  - 4) Witnesses:
    - (a) You will attempt to interview two additional witnesses (Akca and one other) on August 7, 1991 with N. Akyurek and to obtain written statements from them.

- (b) Discuss with Professor Abbasoglu the existence, identity and availability of possible "technician" eyewitness.
- (c) Should police interview Choban?
- 5) Additional information and materials to be supplied:
  - (a) Better copies of maps of Perge site.
  - (b) Names of all people on the Perge site in 1980.
  - (c) Report prepared by Professor Inan for the "Archaeological Excavations in Turkey" program.
  - (d) Copies of publications (including guidebooks) on Perge excavation and site.
  - (e) Copies or list of publications (including those of Professors Krull and Moreno) on Lysipus Herakles.
  - (f) Copies of articles on Levy/White Herakles.
  - (g) Information (name of museum etc.) re additional Perge piece sold by Yegenah.
  - (h) Information (including photographs) on the other 38 pieces excavated from the gallery in Perge and on display in the Antalya Museum.

#### 6) Miscellaneous:

- (a) Copies of photos (and any other materials) sent to you by C. Vermuele.
- (b) Search for the right arm (and other fragments).

Please note that we have promised to give the measurements and a report from you to the attorneys for the MFA and Levy/White by September 30. We will probably also recommend that we exchange full casts of each statue on and before that date.

As soon as the photographs which Scott took at the August 5, 1991 inspection are ready, we will send a set to you. We
